IV. South Carolina Office of Resilience – Mr. Ben Duncan, Chief Resilience Officer, SC Office of Resilience (Section 4, Board Packet)

Briefing: The SC Office of Resilience (SCOR) was established in September 2020. Its purpose is to increase resilience to disasters and reduce or eliminate the long-term risk of loss of life, injury, damage to property, suffering, and hardship. It accomplishes this mission, by lessening the impact of future disasters. SCOR serves the state through housing recovery following a federally declared disaster, mitigation against future flood risks, and resilience planning. Mr. Duncan will address the organization's mission and services and will discuss how SCOR can serve Upstate communities.

 V. <u>ACOG SHIP (State Health Insurance Program)</u> – Ms. Kim Reyes, SHIP Counselor (Section 5, Board Packet)

Briefing: The SHIP program provides seniors with counseling on Medicare and Medicare supplemental insurance. The program also helps seniors when they have a dispute with their insurance company. This service provides the most direct interaction between ACOG staff and the public of any program offered by the agency.
